Vendor and Food Truck Application

- **NOTE:** This application is for ALL days of Highwood Days (Thur. & Fri.) & North Shore Taco Fest (Sat. & Sun.).
- **Vendors may not sell alcoholic beverages of any kind.**
- Spaces are 10' x 10' and include electric up to 20 amps. An optional tent is available for an additional fee of \$150 (see PAYMENT SCHEDULE below).
- Any larger space will be charged an additional fee (see PAYMENT SCHEDULE below). This will be strictly enforced.
- Vendors are required to provide their own lighting, heat source and electrical cords which must be UL approved and outdoor grade.
- Additional electric will be provided at a rate of \$20 for each additional 20 amps (see PAYMENT SCHEDULE below).
