



## Bloody Mary Fest – Vendor Application 2022

Celebrate Highwood's Bloody Mary Fest will take place **Sunday, September 18, 2022**, at Everts Park (130 Highwood Ave., Highwood, IL 60040). Restaurant/Bar participation fee is **\$150** (or \$100 for 2022 seasonal Evening Gourmet Market vendors). Artisan vendor participation fee is **\$50** (or \$35 for 2022 seasonal Evening Gourmet Market vendors).

Application deadline is **Friday, September 2, 2022**. Upon acceptance as a Bloody Mary Fest vendor, a **non-refundable** payment to **Celebrate Highwood, LLC** will be **due in full** on, or before, **Friday, September 9, 2022** or you will incur a **\$50 late fee**.

**NOTE:** Bloody Mary Fest is a ticketed event. Celebrate Highwood holds the liquor license for Bloody Mary Fest, which means all vendors planning to sell alcoholic beverages on-site must purchase liquor directly from Celebrate Highwood. In addition to the fixed vendor fees stated above, there is an additional fee of **10% of gross ticket sales** for alcohol and food sales. These fees only apply to restaurant and bar vendors, NOT artisan vendors. Fees will be calculated and deducted from your ticket sales prior to receiving a reimbursement from Celebrate Highwood. See the Vendor Handbook for more details.

Booth placement is based on returning vendors and first come-first placed. If payment is not confirmed by September 9, 2022, spots will be given to vendors on waitlist. **No exceptions.**

➤ ***Any lighting must be LED and provided by vendors.** Lighting for booths does not count towards additional electrical fees.*

- ✓ *Full Payment* required by **September 9, 2022** to reserve spot as a Bloody Mary Fest vendor.
- ✓ **Signed Vendor Affidavit** – Click [here](#) to access the document or go to the “Vender Info” tab on [www.celebratehighwood.org](http://www.celebratehighwood.org).
- ✓ Copy of current **Certificate of Insurance (COI)** showing general liability of at least \$1,000,000 per occurrence, and naming both *Celebrate Highwood* and *City of Highwood* as additional parties insured. Both parties have the same address: 17 Highwood Ave., Highwood IL 60040.
- ✓ If applicable, a **Lake County Health Department Certificate** associated with the preparation and serving of your food product.
- ✓ If applicable, **City of Highwood Special Event Liquor License number** and **State of Illinois Liquor License number**.

Please e-mail completed application to [sydney@celebratehighwood.org](mailto:sydney@celebratehighwood.org) to request participation. Pending acceptance, a payment made in full must be received on or before September 9, 2022 to guarantee placement at Bloody Mary Fest.

*Please note that receipt of application does not guarantee a placement at Bloody Mary Fest. Celebrate Highwood reserves the right to accept/reject any submitted application. You will be notified of status after receipt of the application.*
