Celebrate Highwood's Taco Fest will take place **Thursday, July 21, 2022**, through **Sunday, July 24, 2022**, at Everts Park (130 Highwood Ave., Highwood, IL 60040). The Fest operates on all dates, **RAIN or SHINE**.

Vendor application deadline is **Friday, July 1, 2022**. Upon acceptance as a Celebrate Highwood Vendor, a **non-refundable** payment to: **Celebrate Highwood, LLC** will be **due in full** on, or before, **Friday, July 8, 2022** or you will incur a **\$50 late fee**.

Vendor participation fee for Taco Fest is **\$250**. Electric hookup up to 20 Amps is included for no additional fee. Booth placement is based on returning vendors and first come-first placed. If payment is not confirmed by July 8, 2022, spots will be given to vendors on waitlist. **No exceptions**.

➤ *Vendors using electricity are **required to bring a 100 ft., 3-pronged outdoor rated and UL approved extension cord** for each hook-up.*

➤ ***Any lighting must be LED and provided by vendors.** No exceptions.*

2. **ALL** vendors preparing and distributing food on site will be **required** to obtain and provide a **Temporary Food Service Permit** from the Lake County Health Department. *If you need assistance with acquiring a food service license, please feel free to contact us so that we may help you through the process.*

3. Vendors are NOT permitted to sell alcoholic beverages at Taco Fest. Celebrate Highwood will have a bar on-site Thursday through Sunday.

4. **Items for Sale:** Please provide a comprehensive list of items you intend to sell, including a *description of the taco/hoagie you plan to sell and how it differentiates you from other vendors.* This information will appear on various marketing materials to help promote your business. **All items for sale must be pre-approved** to prevent duplications between multiple vendors. *(Attach additional sheet if needed.)*

**VENDOR SUBMISSION CHECKLIST OF REQUIRED DOCUMENTATION:**

- ✓ Application due on or before **July 1, 2022**. Once approved, placement is based on returning vendors and first come first placed.
- ✓ Full Payment required by **July 8, 2022** to reserve spot as a 2022 Taco Fest vendor.
- ✓ **Signed Vendor Affidavit** – Click [here](#) to access the document or go to the “Vender Info” tab on [www.celebratehighwood.org](http://www.celebratehighwood.org).
- ✓ Copy of current **Certificate of Insurance (COI)** showing general liability of at least \$1,000,000 per occurrence, and naming both *Celebrate Highwood* and *City of Highwood* as additional parties insured. Both parties have the same address: 17 Highwood Ave., Highwood IL 60040.
- ✓ A **Lake County Health Department Certificate** associated with the preparation and serving of your food product.
- ✓ If applicable, **City of Highwood Special Event Liquor License number** and **State of Illinois Liquor License number**.

Please e-mail completed application to [sydney@celebratehighwood.org](mailto:sydney@celebratehighwood.org) to request participation. Pending acceptance, a payment made in full must be received on or before July 8, 2022 to guarantee placement at Taco Fest.

*Please note that receipt of application does not guarantee a placement at the Fest. Celebrate Highwood reserves the right to accept/reject any submitted application. You will be notified of status after receipt of the application.*
