



The Great Highwood Pumpkin Fest 2024 Artisan Retail Vendor Application

An “Artisan Retail Vendor” is any vendor that sells craft, boutique, clothing and/or specialty items (no food or drink items).
Artisan Retail Vendors are assigned a space within the Pumpkin Fest grounds. Spaces are 10’ x 10’ and **include electric up to 20 amps**. Note the fee does **NOT** include a tent/canopy or weights. You must provide your own. Please see the Pumpkin Fest Vendor Handbook for more information. Additional booth space available for a fee. Any larger space will be charged an additional fee. This will be strictly enforced. Vendors are required to provide their own tent/canopy, weights, lighting, heat source and electrical cords which must be UL approved and outdoor grade. Additional electric will be provided at a rate of \$50 for each additional 20 amps.

- ✓ Copy of current **Certificate of Insurance** (COI) showing general liability of at least \$1,000,000 per occurrence, and naming **Celebrate Highwood** and **City of Highwood** as additional parties insured.
Both parties share the same address: 17 Highwood Ave., Highwood, IL 60040.

- ✓ If applicable, a **Lake County Health Department Certificate** associated with the preparation and serving of your food product.

Please e-mail completed application to sydney@celebratehighwood.org to hold a reservation, but full payment must be received by **September 27, 2024** to guarantee placement.

Please note that receipt of payment does not guarantee a placement. Celebrate Highwood reserves the right to accept/reject any submitted application. You will be notified of status after receipt of the application.
